Notes to accompany financial statements 2016-17

For financial reporting purposes, JCAG is a 'Tier One' association, having a total yearly revenue of less than \$250,000. Tier one associations have an obligation to prepare financial statements that "give a true and fair view of the financial position and performance" of the organisation.

There is no requirement under the Associations Incorporation Reform Act for a tier one organisation to have its financial statement independently audited or reviewed. However, members can vote at a general meeting to require the organisation to have its accounts reviewed. In some circumstances, CAV can direct a tier one organisation to have its financial statements reviewed.

The financial statements have been prepared by Kevin de Vries (JCAG Treasurer) and reviewed by Ann Howe (JCAG committee member). Kevin and Ann believe they present a true and fair reflection of the financial position of the Junortoun Community Action Group Inc.

The accounts of the Association have been constructed to comply with the National Standard Chart of Accounts for charities and other not-for-profit associations. Any reference in the documents to "SCOA" refers to this chart of accounts.

The Junortoun Community Action Group reports and pays GST on an annual basis. A GST refund of \$393 is anticipated for the 2016-17 financial year and the relevant Business Activity Statement has been lodged with the Australian Taxation Office.

During the financial year to 30 June 2017 the organisation did not act as the trustee of any trust.

As at 30 June 2017 there are no mortgages, charges or securities affecting any of the organisations property.

As at 30 June 2017 there are no outstanding or doubtful debts owing to the Association.

Notable grants

Grant income and expenditure is shown as separate reports within the financial statements for purposes of clarity and transparency. These amounts are also included in the income statement and balance sheet that appear at the front of the financial statements.

- The Junortoun Community Action Group received grant income in May 2016 of \$2,500 for the printing and distribution of newsletters to Junortoun residents. This income was fully expended during the 2016-17 financial year, and a corresponding acquittal provided to the City of Greater Bendigo. Copy available on request.
- The Junortoun Community Action Group received grant income in May 2016 of \$2,500 for the construction of nest boxes for installation along the O'Keefe Rail Trail. This very successful project ran throughout the past year and income was fully expended. A corresponding acquittal has been provided to the City of Greater Bendigo. Copy available on request.
- The Junortoun Community Action Group received grant income of \$1,945 in May 2017 from the City of Greater Bendigo to assist in conducting and promoting community events in 2017-18.
- The Junortoun Community Action Group received grant income of \$3,000 in May 2017 from the City of Greater Bendigo to highlight the natural assets (plants and native animals) that exist at Manning Reserve. These funds will be expended in 2017-18.
